

We at the Phoenix Tri-MK want to make sure that all the personal details we hold about you are safe and secure, so we have put together this note to tell all of our junior members and their parents \ guardians, how we make sure we just do that and what to do in case you have any questions for us or want to see what information we have.

We are, what is known as, **a data controller**. This means we have control over how your details are used and who we pass them to.

Sometimes organisations like ours need to appoint an individual called a “**Data Protection Officer**” to make sure that we are being very careful with your information. Our Data Protection Officer is Crispin (*Phoenix Tri-MK Club Secretary*) who can be contacted at [secretary@tri-mk.co.uk](mailto:secretary@tri-mk.co.uk) should you have any questions.

### 1. WHAT TYPE OF DETAILS DO WE COLLECT FROM YOU?

We collect the following **personal details** about you during or after your time as a member, such as

- details of how we can contact you, such as your name, email address, where you live and phone number
- your birthday
- your gender
- membership details including when you signed up to be a member and any date you decide to leave us
- all records of when you contacted us or we contacted you by phone or email or when you asked us to do something
- records that tell us when you were at our events or competitions
- videos and photos of you
- details of family members, coaches and other people we might need to contact in case of an emergency
- records of your rankings including any competition results, what events you have attended and how well you are performing
- any disciplinary information or details of any issues you have us or we have with you

### 2. SPECIAL CATEGORIES OF PERSONAL INFORMATION

We may also hold and use what is called “**special information**” such as information about your health such as any injuries you have \ have had or times you may not have been very well, we will only use it if we have a really good reason to do so such as:

- if it is in the interests of the public and we have a lawful reason to use it
- we need it to help us with a legal case we are involved in
- certain laws allow us to use it
- you have told us you are happy for us to use it

In the following table we refer to these as the “**special reasons**”.

### 3. WHERE DO WE GET THIS INFORMATION FROM?

We collect personal information about you when you and your parent \ guardian jointly complete our membership forms and associated consent forms for:-

- Photography and Filming Parental Consent Form
- Members Code of Conduct
- Social Media Acceptable Usage Statement
- Medical Form

## 4. HOW DO WE USE YOUR INFORMATION?

What do we use your information for?	What type of information do we use?	What reason do we have to use it (this is the boring legal bit...)
<i>To make sure your membership with us runs smoothly and we can provide the very best service for you.</i>	All contact and membership details, any chats we have had	We need all this information to make sure we do a good job in managing your membership with us.
<i>To provide you with merchandise or other services/ products you have ordered from us.</i>	All contact and membership details.  Your parent/guardian's payment information.	We need all this information to make sure you get the [merchandise/products/services] you ordered.
<i>To send you information which we think you might like such as details about competitions and events and any updates from British Triathlon</i>	All contact and membership details.	We need all this information to make sure we do a good job in managing your membership with us.
<i>To send you other information we think you might like or which you have asked us to send to you.</i>	All contact and membership details	Only where you have told us you want to receive this type of information.  If you are under the age of 13 your parent or guardian must have given their consent to allow us to send you marketing messages.
<i>To help you if you have a question or you are not happy with something we have done.</i>	Contact details and any chats we have had.	It is in our interests to make sure we deal with any issues you have quickly.
<i>We will keep all of your details on our files.</i>	All of your personal details.	It is in our interests to hold your details on file so we can deal with any issues with your membership and to make sure we do a good job in managing your membership.  Sometimes we may have to keep your details because the law tells us we have to.  If we use any ' <b>special information</b> ', we will only do so on the basis of one of the ' <b>special reasons</b> ' we talked about previously.

<i>We occasionally carry out research on what events you have attended</i>	Details of the events and competitions you have attended.	It is in our interests to make sure that our membership is targeted and relevant for you.
<i>To promote the sport, our events and the club..</i>	Any photos or videos of you.	Only where you and your parent \ guardian have told us you are happy to use our photos.
<i>To make sure we are keeping up with health and safety.</i>	Details of the events and competitions you have attended.	It is in our interests to make sure we provide you and others like you with a safe place to play your sport.  Sometimes we may have to keep your details because the law tells us we have to.
<i>We will use your details to assess your performance and to find out what else we can do to help you improve your development and training with us.</i>	Details about your performance and the events or competitions you have attended.  We might also hold details about your health and any club or county membership.	We need all this information to make sure we do a good job in managing your development.  If we use any information about your health, we will only do so on the basis of one of the ' <b>special reasons</b> ' we talked about above.
<i>We might use details about your health (including any injuries or disability) to make sure you are playing in a safe environment by making changes to the design of our sports facilities and to ensure you are well enough to participate.</i>	Details about your health.	We will only use this ' <b>special information</b> ', on the basis of one of the ' <b>special reasons</b> ' we talked about above.
<i>To put together all the information we need in case there are any disciplinary or other issues with your membership.</i>	All of your personal details.	It is in our interests to make sure we provide you and others like you with a safe and fair place to play your sport.  If we use any ' <b>special information</b> ', we will only do so on the basis of one of the ' <b>special reasons</b> ' we talked about above.
<i>To make sure we are fairly offering opportunities to everyone.</i>	Name, your birthday, gender, information which part of the world you or your family are from, details about your health and performance.	It is in our interests to make sure we provide you and others like you with the same opportunity to get into sport no matter who you are and where you come from  If we use any ' <b>special information</b> ', we will only do so on the basis of one of the ' <b>special reasons</b> ' we talked about previously.

In some cases we might need the information you have given us to make sure we can do what we say we are going to do with your details.

Other times, we may not need it, but if we don't have it, we may not be able to provide you with the best possible service.

If you have told us we can use your information in a certain way, you can tell us to stop using it at any time, by contacting either or both:-

## 5. HOW CAN YOU STOP US FROM MARKETING TO YOU?

Sometimes we may wish to contact you by email, post or text message to tell you about things we think you might like.

We will only do this if you and your parent \ guardian have told us you are happy to receive these messages and you can tell us to stop at any time by contacting either or both:-

## 6. WHO ELSE MAY USE YOUR DETAILS?

We may send your details to others to help us run our organisation. These are:

- **Anyone you have said you are happy for us to send your details to.**
- **To any regional or governing body:** to help us to improve and keep an eye on developments in the sport.
- **The Government or our regulators:** where the law tells us to do so or to help them with any investigations.
- **Police, law enforcement and security services:** to help them with any investigation, prevention of crime or matter of national security.

## 7. ARE YOUR DETAILS SAFE?

We have put in place security measures to make sure your details don't go missing or get used in a way they shouldn't be.

***Did you know that all 'data controllers' based in the European Union and the UK like us are subject to laws that make sure that your personal details are safe?***

That is why we don't share your personal details to anyone outside of the UK and the European Union

## 8. HOW LONG DO WE KEEP PERSONAL INFORMATION FOR?

We collect personal details from you for different reasons and so we might keep it for different lengths of time.

For example, we might have to keep it for a long time for legal reasons, but most of the time, we will keep your details for 1 year after you last get in touch with us.

It is important to make sure that the details we hold about you are accurate and up-to-date, so make sure you let us know if anything like your email address or phone number changes.

## 9. WHAT ARE YOUR RIGHTS?

### ***Did you know you can ask us to do lots of things with your details?***

You can ask us:

- to tell you how your details are being used
- to provide you with a copy of all details we hold on you
- to correct some of the details we hold if they are not correct or out of date like your contact details for example
- to delete all of the details we hold on you (unless we have a good reason not to!)
- to stop using your details in a certain way
- to send your details to you or another organisation like any club you play at for example

Some of the rights may not always apply to the personal details we hold for you as there are sometimes requirements and exemptions attached which means we need to hold on to certain information and other times the rights may not apply at all.

**DON'T FORGET** though, if you have told us we can use your information in a certain way and you would like us to stop, you can tell us to stop at any time and you can always tell us to stop sending you marketing messages.
