Data Processing Privacy Policy

1. About this Policy

- 1.1 This policy explains when and why we collect personal information about our members and coaches, how we use it and how we keep it secure; and your rights in relation to it.
- 1.2 We may collect, use and store your personal data, as described in this Data Processing Policy and as described when we collect data from you.
- 1.3 We reserve the right to amend this Data Processing Policy from time to time without prior notice. You are advised to check our website <https://www.tri-mk.co.uk> regularly for any amendments (*but amendments will not be made retrospectively*).
- 1.4 We will always comply with the General Data Protection Regulation (GDPR) when dealing with your personal data. Further details on the GDPR can be found at the website for the Information Commissioner (www.ico.gov.uk). For the purposes of the GDPR, we will be the “controller” of all personal data we hold about you.

3. How we protect your personal data

- 3.1 We will not transfer your personal data outside the European Economic Area (EEA) without your consent.
- 3.2 From 25th May 2018 we implemented generally accepted standards of technology and operational security in order to protect personal data from loss, misuse, or unauthorised alteration or destruction.

- 3.4 We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.
